

### **Highlights of Tracie Glaves report:**

The first sighting of the Golden Mussel was reported on October 7, 2024, at the Port of Stockton. Several state, county, and city agencies were informed, and The Regional Water Board was chosen to take the lead. It's more than they can handle.

The major concern is how to stop the spread of the mussels outside of the area to the lakes, rivers and streams. Water intakes in the delta are at risk.

The first concern for the cities is the mussels blocking off the water supply to the fire hydrants, and the city drinking water supply. For Stockton and delta region the weather, water temperature, as well as the calcium level in the delta region is a perfect "storm" for mussel growth.

Surveys from the boat haul-out yards seem to be showing the mussels do not attach to the boat hull's bottom paint IF it is in good condition. Chips and worn spots seem to harbor the mussels. Also, the mussels seem to attach to any <u>metal structures</u> under the water, trim tabs, water intake screens, through hull fittings. They especially like the caulking used to seal any through hull fittings.

Tracie and her team have a couple of boats that have been hauled out, cleaned and are in the process of fitting them with sonic devices ("Hull Shield") to repel the mussels, but unfortunately do not remove the mussels that are already there. Once the boats are back in the water they will have divers inspect the hulls monthly and report their findings. The squadron has asked that they get that information also.

The mussel's larva is microscopic at the beginning of growth, so if you don't see any doesn't mean you don't have any. It takes about a year to reach 1 inch and will grow to 2 inches. Currently, the only way to deal with them is to pressure wash with 140-degree water. But don't let the water run into the storm drains as they just flush back into the delta and start all over again. They can survive approx. 10 days out of the water but only survive in salt water for 7-10 days. Mussels can spread up to 150 miles a year under the right conditions.

A Bay Cruise this fall may be in the squadron's future.

You cannot EAT them as they are poisonous.

They believe the mussels arrived on a freighter from Asia last fall. Tracie also mentioned that The State Lands Commission is responsible for the inspection of all ships as they arrive under the Golden Gate Bridge. Last year only 13% of the ships were inspected. The life span of a Golden Mussel is 5-10 years. Theory is they will live in the delta for up to two years but this is yet to be proven. So, this problem is not a 1 and done.
