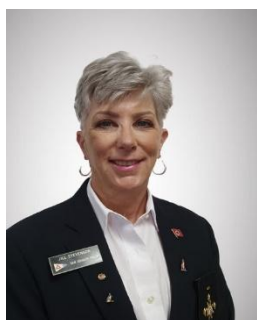

Legislative Report

Current Legislative and Policy Issues Affecting Boaters (Priorities for RBOC)

The state and regional agencies are increasing restrictions on water activities to prevent the spread of golden mussels, prompting significant concern from the boating community.

RBOC is pushing for fair implementation of a producer responsibility program for expired marine flares, recognizing the burden it may place on boaters given there's only one manufacturer.

Boaters continue to oppose the Delta Conveyance Project, even in its revised single-tunnel form, due to its impact on navigation and recreation.

Efforts are underway to ensure any boat registration fee increases are preceded by reforms to make related programs more efficient and equitably funded. Still waiting for trailer bill in the state budget.

Finally, concerns are being raised about the state's approval of E15 fuel, which may limit E10 availability and damage marine engines.
